The Company confirms that on 15 August 2025 it purchased a total of: (i) 29,979 ordinary shares of EUR 0.01 ("**ordinary shares**") on the US Trading Venues<sup>[1]</sup> and (ii) 20,336 ordinary shares on the London Trading Venues<sup>[2]</sup>; in both cases, from Goldman Sachs & Co. LLC, Goldman Sachs International or one of their affiliates, as detailed below.

The repurchased ordinary shares will be cancelled.
